

# What is the Transcare Project?

Transcare, is a two-year initiative co-funded within the European Union's Rights, Equality, and Citizenship Programme (2014-2020). Its primary mission is to enhance awareness and provide education to healthcare providers about ensuring safe and non-discriminatory access to healthcare services for transgender individuals.

### What's the progress so far?

### Report on Learning Outcomes

The Report on Learning Outcomes served as a comprehensive repository of the principal findings emanating from the extensive research undertaken as part of the Transcare project. At its core, the overarching objective of this research initiative was to conduct a thorough examination and systematic evaluation of the prevailing conditions within the Greek healthcare and psychosocial support services landscape.

The primary focus of this inquiry was to scrutinize and analyze the manner in which these services are presently being dispensed to transgender individuals, with the intent of discerning patterns, challenges, and areas for potential improvement within the healthcare and psychosocial support framework.

### Good Practice Guide on fighting discrimination on sexual orientation in health care systems

The fundamental purpose of this Good Practice Guide was to achieve several key objectives. Firstly, it sought to identify and highlight three exemplary practices that can be adapted and implemented in healthcare systems worldwide to combat discrimination rooted in gender identity. Secondly, it aimed to conduct a comprehensive assessment and examination of the existing malpractices within the Greek healthcare system.

These malpractices were identified as prominent barriers for LGBTQI+ individuals, with a particular emphasis on transgender individuals, as they endeavor to exercise their fundamental right to equitable and unbiased access to healthcare services. By shedding light on these critical issues, this guide aimed to foster greater awareness, understanding, and ultimately, positive change within healthcare systems across the globe.



## Coming Up Soon

### 2nd Policy Roundtable

The upcoming meeting will seek to develop proposals for a public health framework with three main pillars: 1) Education, 2) Healthcare accessibility and equality, and 3) Legal and institutional aspects.

Moreover, the event will seek to offer insights into the current status of healthcare and psychosocial support services, with a specific focus on service provision for transgender individuals.
